As a result, during normal use, there is no physical danger of ignition, explosion or leakage of hazardous materials. However, if exposed to a fire, added mechanical shocks or decomposed, these improper handlings would cause the leakage of electrolyte. Moreover, if heated strongly by the surrounding fire, acrid gas may be emitted

**Section 4 – First Aid Measure**
