

The capacity recovery rate in the delivery state (50% capacity of fully charged) after storage is assumed to be 80% or more.  
The voltage for a long time storage shall be 3.0V~4.2V range.  
Do not storage Protected 16340 800mAh Battery haphazardly in a box or drawer where they may short-circuit each other or be short-circuited by other metal objects.  
Keep out of reach of children.  
Do not expose Protected 16340 800mAh Battery to heat or fire. Avoid storage in direct sunlight.  
Do not store together with oxidizing and acidic materials.  
Keep ignition sources away- Do not smoke.
